### **Step 5: COVID-19 Liability**

I acknowledge that I understand the health risks associated with participating in a dance class, namely the potential exposure to coronavirus, a virus that causes serious illness (COVID-19) and may lead to death. I understand that “social distancing” (maintaining a minimum distance of six feet from all other people, regardless of whether they show symptoms of illness) is the primary method recommended by the Centers for Disease Control and Prevention to stem the spread of the virus. I further understand that I am required to maintain social distancing while at the VSD studio, wear a mask in all areas except for the dance room, and practice good hygiene before and upon entry including hand washing and hand sanitizing. I understand that VSD will take my temperature upon entry to the VSD studio. If my temperature is 100.4 degrees Fahrenheit or higher; or if I am experiencing unexplained loss or altered sense of smell or taste, cough or shortness of breath, I may be excluded from the activity. I further understand that I may not participate in class if I have such symptoms or if I traveled outside of the United States during the previous 14 days of taking class at VSD.

I also agree to notify VSD if I have symptoms appear within fourteen (14) days after participating in a dance class at VSD. I consent to VSD notifying any staff member or student of existence of these symptoms. I understand that VSD is not liable for any illness or death that may occur as a result of participating in a dance class at VSD. As a condition for the class(es) that I received, I, for myself, my executors and assigns further agree to release and forever discharge VSD and its agents, officers, employees, and volunteers from any claim that I might have myself or that I could bring on another’s behalf with regard to any damages, demands or other actions whatsoever, including those based on negligence, in any manner arising out of these classes.
